



WAIVER

REFUND POLICY:

Refunds will not be issued for non-attendance at a scheduled class.

DISMISSAL POLICY:

Authorized Parents/Caregivers must sign children out of programs. The only people that your child will be released to are those listed on your information form. All persons authorized to pick up students must be at least 16 years of age. If someone other than a parent will pick up your child, please give us prior written notice.

If there is an emergency and no one on your list can pick up your child, the primary parent/guardian must call the Bricks 4 Kidz Teacher to allow another adult to pick up the child or send a signed note of authorization with that person.

CLASS CONDUCT:

Bricks 4 Kidz reserves the right to release, without refund of program fees, any child whose behavior becomes unmanageable. This action will not be taken without verbal and written warnings. No children will be allowed to intentionally physically harm any other persons or person's property while class is in session. Bricks 4 Kidz highly discourages students from bringing any personal LEGO® Bricks such as mini figures or personal LEGO® models to classes. Bricks 4 Kidz is NOT responsible for damages or loss of any personal property while at a class.

DO STUDENTS TAKE HOME THEIR PROJECTS?

Since we use our LEGO® supplies in classes and camps throughout the year, students do not take home projects or pieces.

STAFF:

Bricks 4 Kidz instructors are individuals who have a great interest and ability in teaching Bricks 4 Kidz programs to students in an exciting way. Each instructor is trained in teaching specific lessons involving the themes in the programs. In addition, all instructors go through a criminal history background check.

I (on behalf of my child) hereby assume the risk, and hereby waive, release, and discharge Bricks 4 Kidz, officers, employees, activity instructors and assistants, and all officers and employees of the school or community center sites where said activity will take place, for any and all claims for damages for personal injuries, or claims for damages to property, which my child or my child's heirs, assigns, executors or administrators may have or which may accrue to my child's participation in this activity. I have read the above and understand important legal rights are being waived.

I understand that the Bricks 4 Kidz teachers are not medically trained in first aid or epi pen administration. I acknowledge that Bricks 4 Kidz advises that if my child has any special medical needs (i.e. epi pen, insulin pump, hemophilia concern, seizure history, heart condition, etc.) that I, the parent or guardian, will be present during class or I will provide a designated adult to be present and responsible for my child should any medical need arise.

I authorize the Bricks 4 Kidz to arrange ambulance transportation in case of accident or acute illness. It is understood that an effort will be made to notify me at the phone numbers I have given in the registration site. If above such action is taken, I understand that the expense of this service will be accepted by me.
